California School Vaccine Requirements

- MMR approved in 1971. Stand alone vaccines for each pathogen approved in 1963, 1967, 1969.
- COVID19 vaccines are not FDA approved for children under 16 years of age. **They are under Emergency Use Authorization only.**
- There is no EUA or approval for children under 5 years of age.
